Prior to accepting your plea of No Contest or Guilty, the court advises you:

It is unlawful for you to possess or transfer a firearm or ammunition if you are convicted of a misdemeanor involving family violence;

If you are not a citizen of the United States of America, a plea of guilty or no contest may result in deportation, exclusion from admission to this country, or the denial of naturalization under federal law.

THIS FORM MUST BE RETURNED along with copy of DRIVER'S LICENSE and PAYMENT FOR DEFERRAL. YOU WILL NOT BE ELIGIBLE FOR DEFERRED DISPOSITION IF YOU HOLD A COMMERCIAL DRIVER'S LICENSE OR HELD A CDL AT THE TIME OF YOUR CITATION.

I authorize the Court to forfeit my payment as a special expense fee at the end of my deferral period or as payment of fine if I do not comply with the conditions of the deferral. **You must comply with the conditions of the deferral order or a show cause hearing will be set and judgment may be imposed resulting in a conviction on your record.**
